Re: Policies & Procedures

Please review the following safety measures implemented for the safety of our students, instructors, parents and staff:

Registration

- All paperwork and full payment of the non-refundable registration fee of \$600 must be submitted by July 1, 2020.
- Student drop off will be at the front door and pick up will be at the back door via sign in/out process. Parents/legal guardians must have proper identification in order to pick up the child.
- Students are only allowed **TWO ABSCENCES**. A student will be immediately dismissed after a **THIRD** absence. .
- No students will be admitted after 9am.

Attire/Lunch

- Students will receive a Ready Set Dance t-shirt
- Students must wear plain black shorts, socks and sneakers.
- Female students will receive 2 leotards and two pairs of tights.
- Male students must wear a plain white t-shirt.
- Students must pack a healthy lunch (i.e. no junk food, chips, etc.), 2 snacks and a bring a water bottle already filled with water.
- Students **WILL NOT** be allowed to leave the building to get lunch from an outside restaurant.
- Parents/legal guardians **WILL NOT** be able to drop off anything (lunch, clothes, etc.) during the day.

Sanitation Process

- Maximum registration for the program is 20 students. The program will be split into two groups of 10.
- There will be NO partnering or hand holding in class.
- We will increase our outdoor activities as much as possible.
- Hand sanitizer stations will be in the front lobby, in each studio and outside the bathroom.
- No outside visitors will be allowed in the studio.
- A face mask or facial covering must be worn to enter the building.
- The studios will be wiped down in between every class transition and fully sanitized at the end of the day.
- Each student must pack 2 masks and hand sanitizer.
- Students will have their temperature taken daily. Students who have a fever or flu like symptoms will be dismissed immediately.

D/B/A OrigiNation Cultural Arts Center, ShapeUp with Shaumba located at 3708 Washington Street, Jamaica Plain, MA 02130, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, for any physical or psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may suffer as a direct result of my participation in the aforementioned Activity, including traveling to and from an event related to this Activity.

I AM VOLUNTARILY PARTICIPATING IN THE AFOREMENTIONED ACTIVITY AND I AM PARTICIPATING IN THE ACTIVITY ENTIRELY AT MY OWN RISK. I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS “WAIVER AND RELEASE” AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center, ShapeUp with Shaumba AND ALL OF ITS AFFILIATES, MANAGERS, MEMBERS, AGENTS, ATTORNEYS, STAFF, VOLUNTEERS, HEIRS, REPRESENTATIVES, PREDECESSORS, SUCCESSORS AND ASSIGNS, FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center, FOR PERSONAL INJURY OR PROPERTY DAMAGE.

If any damage to equipment or facilities occurs as a result of my or my family’s willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any actions of neglect or recklessness.

This Agreement was entered into at arm's-length, without duress or coercion, and is to be interpreted as an agreement between two parties of equal bargaining strength. Both the Participant and OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center, agree that this Agreement is clear and unambiguous as to its terms, and that no other evidence will be used or admitted to alter or explain the terms of this Agreement, but that it will be interpreted based on the language in accordance with the purposes for which it is entered into.

In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect, so long as the clause severed does not affect the intent of the parties. If a court should find that any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed and enforced as so limited.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center, has put in place preventative measures to reduce the spread of COVID-19; however, OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center could increase your risk and your child(ren)'s risk of contracting COVID-19.

I understand that the risk of becoming exposed to or infected by COVID-19 at OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center result from the actions, omissions, or negligence of myself and others, including, but not limited to, OrigiNation Cultural Arts Center,, LLC employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center or participation in programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless OrigiNation, Inc. D/B/A OrigiNation Cultural Arts Center, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.
